Program Overview

Welcome to the JPMorgan Chase & Co. Technology for Social Good: Tech Warehouse Program managed in collaboration with Good360.

Through its technology donation program, JPMorgan Chase assists nonprofit organizations and schools with contributions of refurbished technology that enhance communities and improve individual productivity.

Donations include cleaned and tested refurbished computers, with basic peripherals (for desktops only) and basic OS software. **Donations do not include any technical support or maintenance and equipment will be donated as is.**

Donation Program Eligibility Guidelines

Each organization selected to receive a technology donation may apply once per calendar year and is limited to 12 products annually and 3 per quarter. Good360 recovers its shipping and logistics costs by charging a nominal administrative fee for the technology. The fee must accompany the online application. Requests will only be accepted from the following types of organizations:

- Organizations as described in Section 501(c)(3) of the Federal Internal Revenue Code or recognized U.S. Indian reservations; and/or are exempt under Section 501(c)(3); and are not private foundations (other than an operating foundation described in Section 4942(j)(3).
- public schools (K-12) in partnership with a qualified not-for-profit organization

Provided that any such organization:

- is not listed or sanction by the Office of Foreign Asset Control (OFAC) or listed on any other security watch list

• does not advocate, support or practice discrimination based on race, religion, age, national origin, language, sex, sexual preference or physical handicap.

• does not promote religious faith as one of its explicit goals; and must not have the nomination or election of candidates to political office as an explicit purpose. Programs that operate under the sponsorship of a religious organization that are open to and used by a cross-section of the community and are non-religious are eligible, if there is no requirement to participate in religious organization, yet is available to and used by the general public and does not promote or otherwise require adherence to specific religious principles or practices, is eligible.)

JPMorgan Chase will not provide contributions to:

• individuals;

• organizations whose primary purpose is to promote political views, influence legislation or support candidates for public office;

• churches, houses of worship, religious or sectarian programs for religious purposes, or religious training programs including but not limited to seminaries, theology schools, yeshivas, etc.;

endowments or grant-making organizations classified by the IRS as foundations;

- fraternal organizations;
- state and/or federal governments; and
- nonprofits not currently holding a 501(c)(3) exempt status.
