SitRep - February 21, 2025


Good360 DR Activation Status - Partial Activation

Situation Overview

Response and cleanup activities continue following last weekend's extreme flooding event that impacted portions of the Appalachia and the Southeast U.S. At least 18 deaths resulted from this event with 14 fatalities occurring in Kentucky, 1 in Georgia, and 3 in West Virginia. In areas including Kentucky, Tennessee, Virginia, and West Virginia, immediate response efforts were temporarily halted as early as Tuesday (2/18) as many flooded communities also had to deal with impacts from inbound snowfall. As weather improves, Kentucky is transitioning from search and rescue operations to immediate recovery activities and most power outages have been restored in impacted regions (click here for full list of outages). It was previously reported that a Major Disaster Declaration was approved for the State of Kentucky, however, the expedited request is still being processed. In addition, the Major Disaster Declaration requests for Virginia and West Virginia are also pending.

Potential Hazards

 As of today, the Green River at Calhoun Lock and Dam in Kentucky is at risk of flooding and could crest by early tomorrow morning. Currently, a Flood Warning is in effect for the region.





• In Virginia, Boil Water Advisories are in effect for 5 counties and are currently impacting about 45,000 customers in Kentucky. In addition, approximately 6,000 customers are completely without water access in Kentucky.

Key Highlights from Calls and Agency Reports

Kentucky

- Approximately 321 cleanup requests have been submitted in Kentucky.
 This number is expected to increase as water continues to recede and residents gain access to their properties.
- All water systems are operational, though 27 are at limited operations with 400 fully operational.
- In Leslie County, over 300 homes are flooded w/no access.
- o In Martin County, 4 Distribution Centers are open.
- Preliminary damage assessments show 14 homes destroyed, 73 with major damage, 69 with minor, and 58 affected with slight damage. These are very rough estimates.

Virginia

- The Virginia Department of Emergency Management is currently partially activated and is monitoring requests from the localities.
- o Damage Assessments are expected to resume on Monday, 2/24.
- Virgina Beach EOC is currently at a modified activation status and continues to monitor conditions.

West Virginia

- The region is expecting significant rainfall by the end of next week.
- Approximately 800+ service requests have been submitted. This count could decrease as duplicate requests are identified or may increase as residents gain access to their properties.
- o Several communities are without water due to failed water systems.
- In Raleigh County, several homes incurred damage to heating systems and many more were impacted by flooding.



- In Logan County, major water issues have led to about 20,000 customers with little to no water access. The county is unsure when the water systems will be up and functional.
- The National Guard is conducting damage assessments; counts are forthcoming.
- There are currently about 16 American Red Cross shelters open. There are currently **360 occupants across two states** including the following:

Good360's Response

Good360 Disaster Recovery remains partially activated. We are currently working with at least eight non-profits' active in identifying product needs during this immediate phase of the disaster cycle and are also building out truckloads with the inventory we currently have pre-positioned in our warehouses.

Please note that product deployment has been halted until Monday, 2/24. **Preliminary product needs** include the following:

- 1. Flood and cleanup buckets (including shovels, mops, sponges)
- 2. Mold remediation kits
- 3. Cleaning supplies (i.e., sprays, disinfectants, etc.)
- 4. Tyvek suits
- 5. OTC medicine, insulin, first aid kits
- 6. Hygiene kits, diapers
- 7. Propane tanks (for cooking & portable heating)
- 8. Portable showers
- 9. Dry wall, nails, tape, and flooring




Situation Overview

Response and cleanup activities are underway following this weekend's extreme flooding event that has impacted portions of the Appalachia and the Southeast U.S. including the States of Alabama, Georgia, Kentucky, Mississippi, North Carolina, Tennessee, Virginia, and West Virginia. At least 16 deaths have resulted from this event with 14 fatalities having occurred in Kentucky. While a failed levee in Tennessee led to the evacuation of about 250 residents within the City of Rives, no fatalities have been reported but at least 60% of the homes have incurred severe water damage. To support ongoing relief and recovery efforts in Kentucky, Governor Andy Beshear submitted a Major Disaster Declaration which was approved by President D. Trump, granting individual and public assistance in designated counties (click here for list of locations). West Virginia Governor Patrick Morrisey has also submitted a Major Disaster Declaration request for 13 counties which is currently pending approval. If approved, the hardest hit counties of Boone, Cabell, Greenbrier, Kanawha, Lincoln, Logan, Mercer, McDowell, Mingo, Raleigh, Summers, Wayne, and Wyoming would have access to



FEMAs individual and public assistance programs. Currently, most power outages have been restored in impacted regions (click <u>here</u> for full list of outages).




Potential Hazards


The State of Kentucky is expecting at least six inches of snow today until Thursday (2/20). This incoming weather system will hinder response efforts for those impacted by recent flooding and could potentially lead to higher water levels as the snow melts. As this new system moves in, the following <u>rivers</u> are at risk of cresting in the coming days:

- Green River (KY) and Calhoun Lock and Dam
- Grean River (KY) at Woodbury Upper



- Rolling Form River near Boston
- Kentucky River near Ravenna

 A Kentucky VOAD coordination call will occur daily today through Friday (2/21) at 7:00PM EST.

Key Highlights from Calls and Agency Reports

- There were over 1,000 water rescues in Kentucky and about another 150 in Virginia.
- Search and rescue operations are ongoing in West Virginia, with 3 people reported missing.
- Over 20,000 customers are without water in Kentucky due to water system failures.
- In Kentucky, 2 water treatment facilities are non-operational while 25 are operating at limited capacity. 2 wastewater treatment facilities are also nonoperational with another 37 working at limited capacity.
- Boil Water Advisories are in effect for portions of Kentucky and Virginia.
- In preparation for an incoming snowstorm today through Thursday, Kentucky VOAD has requested that all product deployment into KY be halted until this system has passed.
- Damage assessments will be delayed due to the incoming snow system.
- The State of Kentucky will be providing water and deploying pallets across the state.
- At least 150 counties had flash flood warnings; we will know true impacts once the water recedes, and damage assessments can begin.
- Kentucky anticipates hundreds of homes will be affected by flood water in some way. The count is **not** expected to reach the thousands.
- A mudslide occurred in Letcher County affecting the City of Fleming-Neon & McRoberts. About 5 homes were directly impacted with many roads blocked for in/out traffic.
- There are currently about 30 American Red Cross shelters open. There are currently **595 occupants across four states** including the following:

Good360 Disaster Recovery is currently partially activated. At least five non-profit partners have requested assistance with products during the immediate phase of this incident and we are looking at inventory to see what we may be able to assist with. At three partners are actively responding in Kentucky. Product deployment is to be halted until the current storm system has passed. Current product needs, however, include the following: flood and cleanup buckets, shovels, mops, sponges, OTC medicine, insulin, first aid kits, hygiene kits, diapers, and portable showers.
